The following message outlines some information on how ASOC will proceed with the training and assessment on ASOC's campus.

Check in TAS QR code Requirements

Do I have to check in via the QR Code every time I enter the campus?

It is a mandatory requirement to scan QR code upon entering premises. Therefore, anyone who enters Australian School of Commerce will need to scan the Check in TAS QR code on entry.

What about data and privacy?

The information recorded through Check in TAS is automatically stored in the right format within the Department of Health for rapid response contact tracing, if required, and automatically deleted after 28 days.

COMING TO THE INSTITUTE

What will happen when I arrive at the institute?

When you come to ASOC, admin staff will greet you. You will be asked to hand sanitize and scan in the QR code. If you are fully vaccinated, we may ask you to show your Vaccination Certificate, digital version or a hard copy printout, or a Medical Exemption.
